To provide for the exemption of certain earnings from the retirement earnings test, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Health Care Worker
- 5 and First Responder Fairness Act".
- 6 SEC. 2. EXEMPTION OF CERTAIN EARNINGS FROM RETIRE-
- 7 MENT EARNINGS TEST.
- 8 (a) In General.—For purposes of subsection (b) of
- 9 section 203 of the Social Security Act (42 U.S.C. 403(b)),

- 1 wages paid during the period beginning on January 31,
- 2 2020, and ending on May 11, 2023?, to an individual who
- 3 attests to and provides evidence of being employed as a
- 4 health care professional or first responder during such pe-
- 5 riod shall not be included in the determination of the indi-
- 6 vidual's excess earnings under subsection (f)(3) of such
- 7 section for any taxable year.
- 8 (b) GUIDANCE.—Not later than 30 days after the

- (a) In General.—For purposes of subsection (b) of

- 17 health emergency declared by the Secretary of Health and
- 18 Human Services under section 319(a) of the Public Health

- (b) Issuance of Waivers.—During a public health
- 24 emergency declared by the Secretary under section 319(a)
- 25 of the Public Health Service Act (42 U.S.C. 247d(a)) in

which the Secretary has determined that, wholly or par-

tially as a result of the public health emergency, there is 3 a shortage of healthcare workers, the Commissioner of So-4 cial Security may issue a waiver to an individual who attests to and provides evidence of being employed as a health care professional or first responder during such public health emergency. 8 (c) Report.—The Commissioner shall annually submit a report to Congress describing each waiver that has been issued under this section during the previous year. 10 11 (d) Eligible Individual Defined.—For purposes of this section, the term "eligible individual" means an 12 individual to whom the Commissioner has issued a waiver in accordance with subsection (b). 14 15 SEC. 4.
